We will keep your data for 3 years. Once this time period has expired, we will delete your data by removing it from our database.

What are your data protection rights?

Our Company would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:

The right to access – You have the right to request copies of your personal data from Tiny Trailers.

The right to rectification – You have the right to request that Fantastic Forres correct any information you believe is inaccurate. You also have the right to request Fantastic Forres to complete the information you believe is incomplete.

The right to erasure – You have the right to request that Fantastic Forres erase your personal data, under certain conditions.

The right to restrict processing – You have the right to request that Fantastic Forres restrict the processing of your personal data, under certain conditions.

The right to object to processing – You have the right to object to Fantastic Forres' processing of your personal data, under certain conditions.

The right to data portability – You have the right to request that Fantastic Forres transfer the data that we have collected to another organization, or directly to you, under certain conditions.
